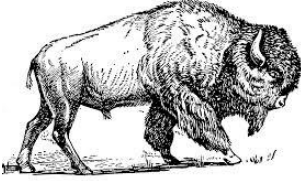

Sheep & Goat Sale – 7:00 PM

All sheep and goats will sell on Friday evening, except for: bottle babies and big horn/shooter sheep and goats, which will sell Saturday morning. All out of state breeding goats must be TB negative and brucellosis test and bangs tested within 30 days of the auction. All sheep & goats must be SCRAPIE ID tagged. Tagging can be done at the barn for \$3.00 per head.

Unsuitable cages and unhealthy stock will be turned away.

Pullorum testing may be done at the barn for \$1.00/head. Contact the sales barn office for a list of testers, in order to test prior to sale.

Hoof stock commission per lot: 10%; \$10.00/head minimum, \$1.00/head vet fee, No Sale: \$10.00/head, Out of state health papers \$10.00, Coggins \$30.00/head.

Caged birds, animals & equipment commission: 20% of first \$200.00 then 10% thereafter, \$2.00/per lot minimum.

*** Iowa law now regulates the sale or possession of dangerous & wild animals as defined under Iowa Code Chapter 717F. All consignors & buyers need to be aware of and abide by the law. ***
